## Informing the Execution of Personal Data Protection Act, Article 9 Paragraph 1

親愛的女士/先生您好,由於個人資料之蒐集,涉及 臺端的隱私權益,兆豐國際商業銀行股份有限 公司(以下稱本行)蒐集 臺端之個人資料時,依據個人資料保護法(以下稱個資法)第九條第一項規 定,應明確告知 臺端下列事項: (一)資料來源 (二)蒐集之目的 (三)個人資料之類別 (四)個人 資料利用之期間、地區、對象及方式 (五)當事人依個資法第三條規定得行使之權利及方式。 Dear ladies and gentlemen: Due to the collection of personal data that relates to your privacy rights, when Mega International Commercial Bank (hereinafter "the Bank") collects your personal data, in accordance with Article 9, paragraph 1 of the Personal Data Protection Act (hereinafter "the Law"), you must be clearly informed of the following items: (1) Data source (2) Purpose of collection (3) Classification of personal data (4) Time period, territory, recipients and methods of which the personal data is used (5) Data subject's rights under Article 3 of the Law and the methods for exercising such rights.

For the purpose and classification, as well as the time period, territory, recipients and methods of which the personal data is used, etc. of personal data collected by the Bank, please refer to the attached table or visit our website.

- 三、依據個資法第三條規定,臺端就本行保有 臺端之個人資料得行使下列權利: According to Article 3 of the Law, in respect of your personal data held by the Bank, you may exercise the following rights:
  - (一) 除有個資法第十條所規定之例外情形外,得向本行查詢、請求閱覽或請求製給複製本, 惟本行依個資法第十四條規定得酌收必要成本費用。
    In addition to the exceptions mentioned in Article 10 of the Law, you may make an inquiry of, review, or request a copy of your personal data. However, in accordance with Article 14 of the Law, the Bank may charge a necessary fee for the cost.
  - (二) 得向本行請求補充或更正,惟依個資法施行細則第十九條規定,臺端應適當釋明其原因 及事實。

You may request to supplement or correct your personal data; however, in accordance with Article 19 of the Enforcement Rules of the Law, you shall properly explain the reasons and facts.

(三) 本行如有違反個資法規定蒐集、處理或利用 臺端之個人資料,依個資法第十一條第四項規定,臺端得向本行請求刪除、停止蒐集、處理或利用。
If the Bank collects, processes or uses your personal data in violation of the Law, according to Article 11, paragraph 4 of the Law, you may request the Bank to delete, cease collecting, processing or using your personal data.

 (四) 依個資法第十一條第二項規定,個人資料正確性有爭議者,臺端得向本行請求停止處理 或利用 臺端之個人資料。惟依該項但書規定,本行因執行業務所必須,或經 臺端書面 同意,並經註明其爭議者,不在此限。
According to Article 11, paragraph 2 of the Law, if there is any controversy concerning the accuracy of personal data, you may request the Bank to cease processing or using your personal data, unless the processing or use is necessary for the performance of a business duty

or a legal obligation, or has been agreed by you in writing, and the dispute has been recorded.

(五) 依個資法第十一條第三項規定,個人資料蒐集之特定目的消失或期限屆滿時,臺端得向本行請求刪除、停止處理或利用臺端之個人資料。惟依該項但書規定,本行因執行業務所必須或經臺端書面同意者,不在此限。

According to Article 11, paragraph 3 of the Law, you may request the Bank to delete or cease processing or using your personal data when the specific purpose no longer exists or upon expiration of the relevant time period, unless the processing or use is necessary for the performance of a business duty, or has been agreed by you in writing.
