Details of rights

1. Right to Withdraw: In the event that Bank processes your personal data with consent, You have the right to withdraw your consent. However, Bank may continue to process your personal data if Bank has other data subject right bases for processing your personal data.
2. Right to Access: You have the right to request a copy of your personal data in our possession.
3. Right to correction: You have the right to request the Bank to correct or update your personal data.
4. Right to Deletion : You have the right to request erase, destroy, or anonymize your personal data. However, Bank may continue to process your personal data if Bank has a legal base that allows it to continue processing.
5. Right to Object: You have the right to request restrict the processing of your personal data under the Bank's legitimate interests. In addition to you have the right to request restrict the processing. If the Bank processes your personal data for marketing purposes.
6. Right to Restriction of Processing: You have the right to request restrict the processing of your personal data. For example, when you want the bank to correct your personal information. or when you request the Bank to prove the reason for the processing of your personal data.
7. Right to Portability: You have the right to request transfer your personal data to other parties.

3. Proof of Identity

For protect your personal information and prevent third parties to exercising your data rights without permission. Please attach the following request documents for verify your identity, The bank will not process your request until you verify your identity.

- Certified copy ID card/ Passport And
- Certified copy house registration

In the event, the applicant is your representative. Please attach following identification in addition to documents stated above.

- Power of attorney And
- Certified copy representative's ID card/ Passport

4. Reserves the rights

The bank reserves the right to decide your request as appropriate under the conditions and terms of Bank policies and related laws. If that Bank refuses to your request, You can file a complaint with the Personal Data Protection Committee.

The bank will consider your request and will notify of the result within 30 days from the date of receipt of your request.
