Please affix original specimen seal and mail back this confirmation form as soon as possible to enable the ATM card. (The Bank will enable the ATM card within one business day after this confirmation is received; if the Bank does not receive this confirmation within one year from the date of application, the Bank shall invalidate and cancel this ATM card for safety consideration. If the applicant wishes to apply a new card again, the new card application shall be carried out.)

The applicant shall reset PIN at Mega's ATM within one month from the date of the ATM card was enabled, or the Bank may lock this ATM card temporarily. The Depositor go to the Bank and enable the ATM card again.

The ATM cards issued by Mega Bank include the following functions initially:

Deposit, withdrawal, PIN change and balance inquiry at domestic ATMs.

- (2) 辦理無存單定期存款及指定／變更無存單定存到期時之處理方式

Open a non-certificate time deposit account and indicate/change the way to deal with the time deposit at maturity.

- (3) 轉帳繳納稅款

Transfer to pay tax payment.

- (4) 於國內接受財金公司規格晶片金融卡交易之特約商店消費扣款。

Domestic POS expenditure account transfer function at the Merchant which accepts FISC system specification.

- (5) 國內外 VISA(限申請 VISA 金融卡)、Maestro(限申請 Cirrus 晶片金融卡、金融信用卡)

特約商店轉帳消費及國內外 MasterCard(限金融信用卡) 簽帳

Purchase payment at domestic and overseas VISA(VISA debit card only)/Maestro(Chip ATM card and combo card only) Merchant; domestic and international debit transaction via MasterCard(combo card only).

5. 若為臨櫃（含聯行及開戶行）領卡者，應出示身份證明文件，並於「申請人（即存戶）」欄位蓋用帳戶原留印鑑及親簽。

If the Depositor obtains the ATM card in person, the identification documents shall be provided, and the Depositor shall sign and affix original specimen seal on Confirmation form.

6. 本確認書內所載各事項如有任何爭執，應以中文文義為憑。

In the event of any inconsistency or conflict between the English and Chinese version of this Confirmation, the Chinese version shall prevail.
