



全球金融網雙重驗證機制申請書

Global eBanking Two-Factor Authentication Request

- 一、立約人茲向兆豐國際商業銀行股份有限公司(以下簡稱「銀行」)申請／變更下列勾選之全球金融網動態密碼安控機制(除簡訊 OTP)或電子憑證登入使用者服務項目，立約人願遵守全球金融網服務約定事項條款。The Contractor agrees to comply with the terms and conditions of Global eBanking Services when applying to Mega International Commercial Bank (hereinafter referred to as the "Bank") for the provision/modification of Dynamic Password Mechanism(except SMS OTP) or electronic certificate login options under Global eBanking services.

- 三、依新加坡金融主管機關規定，在新加坡提供網路銀行服務均須使用雙重驗證機制功能以增加交易安全，為符合該國規定，本行全球金融網用戶若有申請新加坡分行帳戶者，均必須申請以動態密碼安控機制(除簡訊 OTP)登入網站。Pursuant to the regulations of the Monetary Authority of Singapore, all Internet Banking services in Singapore must be protected using two-factor authentication for better transaction security. To comply with the country's regulations, the Bank requires all Global eBanking users with accounts opened under the Singapore Branch to apply for the Dynamic Password Mechanism(except SMS OTP) option to login to the Internet Banking website.
